

#### Children at Risk Today

- ♦ A stunning 37 percent of the world's children, more than 674 million, live in absolute poverty (Luis Bush 4/14 Movement)
- ▶ Malnutrition and starvation kill some 16,000 children under the age of 5 daily (Make that 29,000 children if you include preventable diseases) (UNICEF and Bread for the World)


